#### **For Sheds, Fences, Landscape changes, other minor Additions, Alterations, or Improvements**

- ☐ Completed Application for Design Review Submittal – Minor Additions/Alterations
- ☐ Current color picture of front of home
- ☐ Picture or drawing of your current lot clearly showing the lots boundary and location of alteration, shed, fence line with gates indicated, etc.  
Google Maps print out, Eagle County GIS, or lot survey are all acceptable
- ☐ Picture or drawing with detailed measurements of the shed, addition, improvement, fence panels, gate panels, etc.
- ☐ Pictures and/or descriptions of all materials to be used
- ☐ Color pictures or sample swatches of the final colors with details of the color scheme, if applicable, and not indicated or different than the materials pictures  
Example: Color sample #1 for shed body, color sample #2 for shed trim
- ☐ Contractor proposal, if applicable

#### **For change of Exterior Paint Colors (if all colors will remain exactly the same, approval is not required)**
